A. EIRP General Activities:

1. Provision of Orthotics : In May 2022, AWMH Children received orthotics and Hearing aids from Vatsalya Trust, Kanjurmarg. Total 15 children were provided with orthotics and 2 Hearing aids.







2. Sponsoring Medical Intervention: AWMH sponsored a child for orthopaedic surgical Intervention for correction of Foot deformity.

AWMH trustee Ms. Swaroopa Modi Sponsored a child for a child from Mulund centre for her Foot deformity Correction surgery costing Rs.40000/-.

Megha Pawar is diagnosed with Club foot deformity and unable to walk. following Surgery by Dr. Mudit Shah, paediatric Orthopaedic Surgeon in Chembur, she is now able to maintain standing and initiated walking with min support.

3. Staff Learning and training: Every month in EIRP staff meeting, a topic and case study is discussed among staff.

The therapists, teachers and psychologists upgrade their skills by case studies, this allowed us to access more expertise to meet the challenges of difficult child- cases, and provide better EI service to the beneficiaries.

Discussion on topics related to Early Intervention during monthly EIRP Staff meeting were conducted regularly.

- **a.** Speech therapy Intervention in Cleft Lip and Palate, Presentation by Ms. Shraddha Shanivare (Speech and language Pathologist).
- **b.** Developmental Coordination Disorder, presentation by Ms. Sheetal Aidale (OT).
- **c.** Use of Audiometry in Speech Therapy, presentation by Ms. Shraddha Shanivare.



4. Operation of New equipment:

WIPRO Foundation provided one time grant of Rs.23.3 lakhs, under their CSR program to equip our 5 EIRP centres.

AWMH EIRP centre were equipped with new therapeutic devices and teaching and learning activities, including evaluation and Intervention tools. The equipment is being used in the centres with very good response from the children.

- a. Sensory Integration Therapy: Tactile Stimulation equipment
- b. Vestibular and Proprioceptive Stimulation equipment
- c. Physical Exercises and Positioning Equipment
- d. Visual Perceptual Activities (Problem solving puzzles and games)
- e. Special Education Teaching Aids
- f. Speech therapy Assessment and Intervention tool

Children empowered with the tools and equipment help them through their developmental challenges, so that they may reach their full potential. Therapeutic devices and equipment are used to increase, maintain, or improve the functional capabilities of children with disabilities. The kits will enable the children's learning through play. The end objective is to make the child develop potential for increased academic readiness and social adaptability for interaction with their peers. The computer aided speech and language therapy assessment and intervention tools provide diagnostic and treatment for speech and language disorders. Interactive application of audiometry and special support system help to develop different phonatory skills including voicing, speech intensity, breathing, voice tone and pronunciation of the set of sounds.













5. 17th May 2022- Meeting with Dalal Family Foundation (DFF), through Zoom Conference call.

Ms. Meena Parekh, Cdr. Shrirang Bijur, Mr. Durgesh Koppikar and Dr. Shital Fulzele attended the meeting.

Following points were discussed during the meeting-

a. Case Load -Average of 56 registered children from Ghatkopar (ASD/CP/Speech and Hearing / Developmental Delays / Down's Syndrome) and Khetwadi centre (ADHD / CP / Learning Disability / ASD) EIRP centre are receiving Early Intervention in a month supported by

DFF. There are few new referrals from neighbouring hospitals / clinics for admission to EIRP centre in AWMH after lockdown when centres reopened.

- **b.** AWMH EIRP centre were equipped with new therapeutic devices and teaching and learning activities, including evaluation and Intervention tools.
- i. Sensory Integration Therapy: Tactile Stimulation equipment.
- ii. Vestibular and Proprioceptive Stimulation equipment.
- iii. Physical Exercises and Positioning Equipment.
- iv. Visual Perceptual Activities (Problem solving puzzles and games).
- v. Special Education Teaching Aids.
- vi. Speech therapy Assessment and Intervention tool.
- c. Children empowered with the tools and equipment help them through their developmental challenges, so that they may reach their full potential. Therapeutic devices and equipment are used to increase, maintain, or improve the functional capabilities of children with disabilities.
- d. Request for sponsorship of EIRP center in Mankhurd AWMH Mankhurd center is currently located in PMGP colony (Case load 32 registered children), Mankhurd west in a residential flat. It is very compacted area of around 200sq.feet which is not suitable for performing some therapeutic exercises including Sensory Integration therapy and gait training in children with physical disabilities due to space constraint. AWMH requested DFF to sponsor Mankhurd center, so we can shift the center to bigger and spacious rooms for individual therapy (occupational and sensory integration therapy, Speech and language therapy, Special education and preschool stimulation)
- e. Improving Early Intervention services through staff increase, so AWMH can provide services to a greater number of beneficiaries- Average of 160 children are receiving early Intervention including Occupational therapy, Speech and Language therapy and Special education in 5 EIRP centres located in Khetwadi, Ghatkopar, Mulund, Dombivali and Mankhurd. Each centre has one Special educator as centre head, Occupational therapist coming thrice a week and Speech therapist coming twice a week. If we increase staff (2 special Educator in 1 centre), we can improve quality of services through increased number of regular sessions, also will be able to increase number of children through new admissions every month.

- 7. **Home Visits**: TISS Interns, students of social science conducted home visits of 30 children from EIRP centre in April and May 2022. During their visit they observed environment of child's Home, they also interview family to understand parent difficulties and challenges for receiving regular therapies during lockdown.





FROM SPORTS DESK
